The House P&E subcommittee on constitutional amendments meets **Monday at 8 AM** but the agenda does not include the last surviving redistricting bill -- **Senator Vogel's SJ284**. *This bill is important to our continuing effort to ensure every citizen's vote is counted.*

Calls are needed now to ask the committee members to insist that this bill be heard and **supported**. Only a few days remain in the session so this bill must be heard next Monday!

OPPOSE HB1318 (Del. Campbell) that requires a copy of a Photo ID when mailing a request for an absentee ballot. Registrars do not have a photo ID for matching what would be sent and would be burdened with unnecessary paperwork, so it is essentially useless to send a photo ID.
