## Highlights: LWV-VA 37<sup>th</sup> Annual Convention Is Action-Packed



Saturday, 3:15: "Redistricting: What it is. Why it is needed. How you can help."

LWV-VA Program Director Linda Rice has provided the main theme for the convention, as stated above. She has rounded up a panel of speakers designed to help us understand the issues, how they fit into a larger context, and what Leaguers need to know about being even more effective advocates.

Rice and Lois Page, LWV-VA Voter Coordinator, have also assembled a "Tool Kit for Redistricting Reform" which will be given to all attendees. The kit will contain a series of articles, maps, and talking points designed to be used to advocate on the <u>local level</u>, where many feel is the best hope for reform.

**David L. Bailey**, whose legislative directory, *Virginia Capitol Connections*, is *the* directory used on Capitol Square and throughout the Commonwealth. Twenty years ago he created *Virginia Capitol Connections Quarterly Magazine*, and it flourishes as a nonpartisan vehicle that helps inform and educate the public. His

Election Night News has provided statewide coverage of General Assembly elections for more than a decade. In 2009 he created *This Week in Richmond*, a weekly Virginia public affairs TV show filmed at the Capitol for Blue Ridge Public Television. *This Week in Richmond* is now virtually statewide – shown on four Virginia PBS stations.

**Ellen Buchman** is Vice-President for Field Operations for the Leadership Conference, "the nations premier civil and human rights coalition." The Leadership Conference on Civil and Human Rights Field Department (the field team) provides grassroots consultation, advocacy coordination, support, and

assistance to national, state, and local organizations regarding field campaigns around important civil and human rights issues. The team is based in Washington, D.C., with a satellite office in Atlanta, Georgia.

Nationally, the field team convenes and provides field outreach and guidance to the coalition's more than 200 national civil and human rights organizations on a broad range of issues. With that focus, the field team provides field outreach and advocacy, and public education campaign guidance, on a broad range of issues.

The Education Fund arm of the organization offers a tool kit for advocacy. "Our goal is to provide you with the basic structure and strategies needed to plan and carry out an effective grassroots public education or advocacy campaign."

**Nick Mueller** is an attorney in northern Virginia who specializes in election law, including redistricting law. He is a graduate of Xavier University in Cincinnati, Ohio and the William & Mary School of Law in Williamsburg, Virginia. While at William and Mary he drew the winning map in

the 2011 Virginia College and University Redistricting Competition. After law school, he served as a law fellow at the National Education Association and has since consulted with organizations advocating for redistricting reform.

## Saturday, TBA.: Launch of LWV-VA Leadership Institute

LWV-VA 1<sup>st</sup> VP Sue Lewis introduced the concept of a Leadership Institute, an in-depth learning experience on all facets of the League, at the last State Board meeting in March. She subsequently agreed to be in charge of launching this initiative by serving on the Board for the next two years as its director.

The purpose of the Institute is to identify and mentor new leaders to serve in various positions of the local or state League. The current plan is to hold the Institute on 3 different Saturdays, spread out through the year, at LWV-VA headquarters in Richmond. The goal will be to invite 12-15 sponsored and accepted applicants who would arrive in Richmond the night before and gather for dinner and networking.

The target topics include board administration, membership, position support, and voter service. Each component would have a group project connected with it.

Sue expects to hold a special **pass-the-hat fundraiser** during the banquet Saturday to help fund the project. Each applicant will pay a \$49 application fee which can be paid by the applicant or a sponsoring League. More details will be forthcoming during the banquet.

Saturday, 8:00 p.m. Introduction and special recognition for Rebecca Young-Marquardt, administrator of the Virginia Gwathmey Young Memorial Fund which has financed a number of state League initiatives over the years, including the General Assembly Legislative Directory. Rebecca and her physician husband Mark are founders of Volunteer Med Partners in Ecuador but have worked in the field of public health in many parts of the world.

Saturday, 8:15 p.m.: Keynote speaker on the subject of Hydraulic Fracturing or "fracking" which is being considered for a program study for the next two years. Speaker details are being worked out as we go to press. A separate Constant Contact notice will update this information shortly.

Saturday, 9:30 p.m./and Sunday, 8:00 a.m.: Caucuses on subjects on interest: Convention planners have already received requests for caucuses on gun safety, redistricting, and fracking. Other may be announced.

## **Program Issues to Come Before the Convention**

Several important program issues will come before this year's LWV-VA 37<sup>th</sup> Annual Convention.

Attendees are being asked to concur on the following proposal for a policy update, as submitted by the Fairfax Area Board of Directors:

- 1. Adoption of a concurrence "in support of removing the barriers to employment for persons with criminal records" at the convention will provide both the Virginia LWV and its member local Leagues the opportunity to support "Ban the Box" and similar proposals in the future. Some Leagues may already be quite familiar with this issue through their participation in local re-entry councils and activities. - 2. We will also be asked to vote on the following **program-**related resolution.

Fairfax Area, on the heels of a series of studies and a public forum on firearms safety (studies and forum summary may be found at <a href="http://www.lwv-va.org/education.html">http://www.lwv-va.org/education.html</a>) has submitted the following:

- "Whereas the League of Women Voters of the United States supports regulating firearms for consumer safety;
- ➤ Whereas studies show that the risk of homicide in a domestic violence situation increases by 500% when a firearm is present;
- ➤ Whereas Virginia laws lack key measures to help protect victims of domestic violence from firearm injury or death at the hands of their abusers;

- ➤ Whereas an analysis of publicly reported firearms deaths in the twelve months after the mass shooting in Newtown, Connecticut, showed that at least 100 children across the United States were killed in unintentional shootings and that 2/3 of these unintended deaths took place in a home or a vehicle that belonged to the victim's family most often with guns that were legally owned but not secured;
- ➤ Whereas analysis of school shootings in the 14 months since the mass shooting in Newtown, Connecticut perpetrated by minors and where the source of the firearm was known, showed that in 75 percent of the shootings the attacker obtained their guns from home, and
- ➤ Whereas research shows Child Access Prevention Laws are effective at reducing firearm deaths among children;
- Therefore, be it resolved that we the representatives of the League of Women Voters of Virginia assembled at the 2015 League of Women Voters of Virginia Convention call upon the board of the League of Women Voters of Virginia to advocate strongly for laws at the state level that more effectively prevent domestic abusers and stalkers from purchasing, accessing or possessing firearms and laws that require adults to bear the burden for the injury, death and damage that results when a child accesses an unsecured or improperly secured firearm.
- 3. Finally, the LWV-VA Board of Directors is asking for a vote on a **recommended new study on "Fracking"** which has been worded as follows by LWV Charlottesville:

The current LWVVA natural resource positions do not address recent developments in Virginia of hydraulic fracturing ("fracking") and energy pipelines. Fracking affects health as well as natural resources. Fracking and pipeline effects go beyond the current LWVVA positions. LWV-VA recommends that it go forward as a new study under Natural Resources.

4. Note: Other program-related resolutions may yet be offered.

# State Board Of Elections Decertifies WinVote Voting Equipment

Richmond – The State Board of Elections (SBE) decertified the AVS WINVote equipment at its public meeting today. The WINVote system is currently used in 30 localities, totaling more than 560 precincts around the state. This decision was reached after careful review of the serious security concerns identified in this system, feedback from election officials across the Commonwealth, and public comments from Virginians, technology experts, and other stakeholders. Decertification means the WINVote system can no longer be used in elections in Virginia, effective immediately.

In response to the widely reported issues experienced by Virginians on Election Day in 2014, Governor McAuliffe called for an investigation into voting machine irregularities. SBE unanimously approved a proposal from the Commissioner of Elections to conduct the first comprehensive review undertaken of voting equipment used across the Commonwealth. The meeting was held shortly after serious security concerns associated with WINVote machines were uncovered by the Department during the ongoing review of voting equipment. Local League presidents and State Board members gathered in Richmond on March 12 for a summit meeting to exchange ideas and let the Board know help they need to carry out their responsibilities. This one-day meeting focused on the following categories: Communications, Administration, Membership, Leadership, Action/Advocacy and Voter

Service—all key elements of League efforts.

One League president remarked, "I feel like the Board really was interested in listening to our concerns and trying to help us." Discussions were lively, positive and informative, especially when members related experiences their League faced.

Top concerns raised include:

- 1. Work with coalitions to bring about redistricting reform, eliminating gerrymandering
- 2. VOTE411 continue to defray the costs, provide training, and publicity
- 3. Utilize software to notify constituents of targeted legislators on specific committees
- 4. Send out Action Alerts in a more timely fashion to maximize volume of mail on various issues
- 5. Attract young people (20-40 years) who are more issue oriented by going where the congregate
- 6. Develop instructional webinars to educate our members
- 7. Speed up the program planning and concurrence process, sharing studies done by other Leagues
- 8. Highlight our core competency in voter registration, voter rights, elections, democratic process and non-partisanship
- 9. Establish a system to train interested League members to track a particular issue they are passionate about
