It's time to make a plan to **vote** at the polls this **Tuesday**, **November 8th**. This year's election will be the first in over 50 years without the full protection of the Voting Rights Act. Despite countless attempts to suppress voter turnout, people across Virginia are more motivated than ever to get to the polls -- to vote for racial justice, for immigration reform, for quality public schools and lowering student debt. The following information echoes a recent newsletter from the New Virginia Majority that we want to pass on. They are urging us to make a plan to ensure our voices are heard on all these issues. Are you ready to play your role in our democracy and exercise your right to vote? **Here are some tips to help you prepare for this important and historic Election Day.** 

#### Do you have a plan?

- Double check the weather.
- Be prepared for long lines!

#### Do you have a valid photo ID?

- Virginia law now requires all voters to show an <u>acceptable form of photo ID</u> at the polls.
- You can apply for a FREE voter photo ID card at any voter registration office throughout the year, even on Election Day.

#### Do you know what's on your ballot?

• Knowing who and what you're voting for before you get to the polls empowers you to make informed decisions for yourself and your community. <u>Click here</u> to find out what's on your ballot in Virginia.

Leaguers all over the state spent hours helping people register to vote—at schools, farmers markets, naturalization ceremonies, grocery stores—we encouraged them to vote online, we supported the extension of the registration period when process broke down. Starting back at the time of the primary, we found dozens of ways to send out information about voting

times and places and voting regulations. We took part in a law suit to stop the purging of voters illegally. We set up local issue forums and candidate debates and meetings so as to accomplish our core mission of having voters be informed.

We think we can count on legislation being proposed during the next General Assembly that will try to limit access to the vote. The fight to end gerrymandering will be reaching a critical stage. We have seen what has happened to voters in North Carolina, just across the border. We all must remain vigilant during this next legislative cycle. The League's efforts to protect the vote has been going on for 96 years; we have had a lot of experience!!

### **Abingdon League Hosts "Talk Backs"**

Washington County League of Women Voters provided panelists for "Talk Backs" following October productions of Abingdon's Barter Theater productions of "Winter Wheat," by Catherine Bush. It is a musical about the vote by a Tennessee legislator that allowed the 19<sup>th</sup> Amendment to be implemented. Leaguers took the opportunity to talk about the League's crucial role immediately following the granting of suffrage to women with their plan, still in place after 96 years, of educating and empowering all voters. Virginia State Board Co-President Lois Page, and Communications Director Ron Page were guests of Washington County President Merry Jennings for the Oct. 29 production. Lois had the opportunity to serve as a panelist and welcomed the chance to talk about the Turning Point Suffragist Memorial. They also explored with the play producers the idea of putting on the play in the northern Virginia area.

# Women's Legislative Round Tables and League Lobby Day Offers Opportunities to Make Your Voice Heard

Join Leaguers from around the state as we gather in Richmond on February 1 for a day of lobbying on various issues coming before this session of the General Assembly. The day starts at 8:30 a.m. as we welcome legislators making brief talks about their priorities and plans, followed by visits to Delegate and Senate offices. Many other organizations will be in Richmond making their voices hear. Afterwards we will have lunch at the Tobacco Warehouse with members of other organizations.



However, Lobby Day is not the only day we hope to see you in Richmond. WLRTs are every Wednesday morning during the session: **January 18 and 25**, **and Feb. 1**, **8**, **15**, **and 22**. You may be able to have your hotel and mileage paid for if you come the night before, attend a gathering of Leaguers to polish your lobbying "elevator speech," and then at least visit the offices of your Delegate and Senator. Stay tuned for details in the next few weeks.

#### **Pre-Session Event Attracts Over 100 Attendees**

An overflow crowd was on hand in Senate Room 3 of the State Capitol to hear presentations from 17 representatives of non-profits and 4 Secretaries from the Governor's Cabinet. This annual event, held on Wednesday, Dec. 7, and sponsored by LWV-VA, provides a unique opportunity for Leaguers and friends to learn what other groups will be advocating and what cabinet members expect will occur during the upcoming General Assembly.



Secretary of Finance Ric Brown, Secretary of Administration Nancy Rodrigues, Secretary of the Commonwealth Kelly Thomasson, and Secretary of Natural Resources Molly Joseph Ward all thanked the League for its nonpartisan efforts for voter rights. Also in attendance was Commissioner of Elections Edgardo Cortes, who pointed out that this election a record number of Virginia voters registered online and voted.

According to Co-president Lois Page, upon the conclusion of the Pre-Session, "We were awed once again by the compassion, determination and dedication of these civic volunteer activists who want what is best for all their fellow Virginians."


constituents.

# LWV-VA Is Looking for a New Legislative Coordinator

Carol Noggle, Legislative Coordinator, will be retiring from the Virginia Board on June 30, 2017, after many years of faithful service. In order to ensure a smooth transition with her successor, the Board is looking for a volunteer to "shadow" her during the upcoming legislative session of the General Assembly before taking over as a Board member in July.



The position, primarily between December and March, entails:

- Testifying on selected legislation. Present League position on bills to legislative committees and elected officials. Monitor action in committees and applicable meetings.
  - Monitoring House and Senate daily sessions for legislators' debate on applicable bills.
  - Maintaining testimony files and legislator interviews.
- Coordinating selection of legislative priorities based on LL interest, input from state Board members, awareness of bills and issues likely to come up during the session, and legislation considered for initiation by LWV-VA.
